Can Allied Irish Bank (GB) change the interest rate?	<ul style="list-style-type: none"> No. The rate of interest will not change during the course of the term. The rate applied at reinvestment may differ to the rate provided on account opening. 																									
What would the estimated balance be at maturity based on a £5,000 deposit?	<p>The balance in your account at maturity will depend on how much you deposit and when, the interest rate, and the term of your investment. How do I open and manage my account?	<ul style="list-style-type: none"> You can open an account by calling us on 0345 6005 204. It is available to business and personal customers aged 18 and over. For business customers a minimum balance of £5,000 is required to open an account. For personal customers a minimum balance of £800,000 is required to open an account. There is no maximum lodgement. No additional lodgements permitted during the term of your investment. You must provide us with a maturity instruction prior to the maturity date. If we do not hear from you, we will reinvest your funds daily which may be at a lower rate. You can provide us with a maturity instruction by calling us on the number below. We will write to you 14 days before your maturity date reminding you of the options available when your account matures. 																									
Can I withdraw money?	<ul style="list-style-type: none"> No. Withdrawals cannot be made during the term of the investment. At maturity you can choose to reinvest all funds, withdraw some of the funds and reinvest the balance or withdraw all of your funds and close the account by calling the number below. In exceptional circumstances and at our discretion a withdrawal before maturity may be allowed. A charge will be payable. The amount of the charge, which will comprise an administration cost of £50 and a breakage cost, will be advised to you at the time of withdrawal. If a withdrawal is made during the fixed term, the stated interest return may not be achieved. Please ensure that you have other sources of income and/or savings to meet your expenditure requirements during the term of this account. 																									
Additional information	<p>Tax</p> <p>We do not deduct tax from the interest we pay you in accordance with current legislation. The law relating to taxation is always liable to change.</p>
